- Newly admitted New York attorneys (attorneys admitted to the New York State Bar for two years or less) cannot earn CLE credit in the category of Diversity, Inclusion and Elimination of Bias.
- Experienced New York attorneys due to re-register on or after July 1, 2018 must earn one credit hour in Diversity, Inclusion and Elimination of Bias. Experienced attorneys who earn more than one credit in this category in their reporting period may use such credit to meet the remainder of the 24 credit hour biennial requirement (except for the Ethics & Professionalism credit requirement).

## **Description:**

Part I: Recent research demonstrates that lawyers suffer from mental health and substance abuse problems at significantly higher rates compared to other professionals as well as the general population. Stigma is the number one obstacle preventing lawyers from getting the help they need to address a problem.
